- 2. The document verification for these candidates is scheduled on **19.12.2022 (Monday)** at RRB Office, Thampanoor, Thiruvananthapuram as per the reporting time mentioned above.
- 3. E-Mail/SMS to this effect will be sent to the registered Mail ID/Mobile number of the candidates advising them to download their e-call letter and travelling pass (to those who are eligible) and to report to this RRB for document verification on the given date and time mentioned in the e-call letter.
- 4. The candidates called for DV should produce all the Original Certificates and mark sheets (semester wise for Degree) along with two sets of photocopies in A4 size as detailed in the CEN and e-call letter issued for document verification. Where certificates are not in "English / Hindi", self attested translated version in Hindi or English

should be produced. Caste/Community certificates, declarations, etc produced during the DV should be strictly in the prescribed formats given in the CEN. Where the certificates issued by the concerned authorities is in different format, the same should be obtained as per the prescribed format given in the CEN.

- 5 Shortlisted candidates should also bring six (6) passport size photographs NOT MORE THAN THREE MONTHS OLD. Candidates should also bring candidate's foil of e-call letter for1st and 2nd stages of CBT and CBAT. Mobile phones or other electronic gadgets are not permitted during Document Verification as well as during Medical Examination.
- 6. Candidates have to upload scanned certificates/documents as mentioned in the DV e-call letter in the portal : https://oirms-ir.gov.in/rrbdv/ which will be active by 13.12.2022. The instructions for uploading the certificates/documents is available in the portal.
- 7. The Medical Examination (ME) will be done on the next day of DV at any of the nominated Railway Hospitals under Southern Railway. A fee of Rs. 24/- needs to be paid for medical examination. It is requested that candidates should bring necessary change for paying the medical examination fee. Candidates are advised that they should be prepared to stay for 3-4 days for document verification and medical examination at their own cost. The shortlisted candidates should carry a valid Photo Government ID which should be shown, if required, for DV or ME.
- 8. Shortlisted candidates for DV should report on the given date and time and failure to report on the scheduled date for DV would be lead to rejection of their candidature. Kindly note that no block date for absentee candidates have been scheduled as there are only six candidates. However, in case any candidate is not able to attend DV on the scheduled date and time on account of appearing in University/Government examinations or personal sickness, such candidates are advised to inform this RRB in advance through mail to rrbtvm.ker@nic.in and rrbtvc1@gmail.com attaching supporting documentary proof in support of their not been able to attend the DV on the scheduled date and time. No other reason for absence would be considered. Such requests would be considered on merit and candidates informed and if required DV for such candidates would be held later. The decision of RRB in this regard would be final and no further correspondences would be held further. It is, therefore, in the interest of candidate to ensure that they attend the DV on the scheduled date itself.
- 9. The candidature of all the shortlisted candidates is purely provisional and is liable to be cancelled at any stage of recruitment or thereafter, in case of any inconsistency / deficiency / discrepancy detected in the information / documents submitted by them or any malpractice on their part coming to the notice at any stage of the recruitment process or thereafter.
- 10. Candidates are advised to regularly visit the official RRB Thiruvananthapuram website mentioned above for all updates and BEWARE of FAKE websites put up by unscrupulous elements/touts. Any information/ notices being circulated in the social media regarding RRBs may please be ignored.
