**Notice for sending the latest Community & Caste certificate through Email by all the "Application Accepted" candidates of CEN No. 06/2024 (Under Graduate) who belongs to specific Castes but mentioned the Community as SC in their submitted online application**

**Attention to all applied candidates whose applications have been accepted (Provisionally/Conditionally) for CEN No. 06/2024 (Under Graduate) and (a) also belongs to PAN / SAWASI / PANR / TANTI - TATWA (तांती-ततवा) castes originally and (b) also belongs to Bihar State or migrated (temporarily /permanently) from Bihar state only to other states and (c) also mentioned as SC Community in 'community' field in their online application.**

**In the light of Hon'ble Supreme Court Judgement in:**

*Supreme Court Civil Appeal No. 18802 of 2017 between Dr. Bhim Rao Ambedkar Vichar Manch, Bihar, Patna and the State of Bihar & Others., Judgement dated 15.07.2024*

1. Candidates who have mentioned their community as **SC** in online application and also **(A)** **ORIGINALLY BELONGS** to PAN / SAWASI / PANR / TANTI-TATWA (तांती-ततवा) CASTE AND **(B) BELONG TO BIHAR STATE or MIGRATED (TEMPORARILY / PERMANENTLY) FROM BIHAR STATE ONLY TO OTHER STATES** should **submit** the following details in the manner mentioned hereunder:
  - a) Candidates must submit a self-attested scanned copy of their latest caste certificate, **issued on or after 01-09-2024.**
  - b) To consider the candidate (belongs to Tanti-Tatwa caste) under OBC-NCL (Non creamy layer) category, he/she should submit caste certificate as per '**Form VII A**' issued by competent revenue authorities of Bihar state government or equivalent certificate in other states, which is also equal to Annexure – II of CEN No. 06/2024 (Under Graduate).
  - c) The scanned copy should be in PDF format and sent exclusively via the Email ID registered during the online application process.
  - d) The Email must also include the following details: Application Registration Number, Applicant Name, Registered Mobile Number, CEN Number, Old community & caste and revised community & caste.
  - e) The email should be sent to the RRB- Ahmedabad official Email ID: '[as-rrbadi@nic.in](mailto:as-rrbadi@nic.in)'
  - f) **The last date** for submitting self-attested scanned latest community & caste certificate through their registered Email to above Email ID is on or before **01-06-2025**. (23:59 hrs). All the candidates who have submitted latest community & caste certificate, will be considered for further stages of recruitment as per their revised caste/community.
2. If any of such candidates who do not respond to this notice and do not send their self-attested scanned latest caste certificate issued on or after **01-09-2024** by competent authority **till the last date of submission i.e., 01-06-2025**, will be later shortlisted for further stages of recruitment as per the community (SC) mentioned in the online application. These candidates must mandatorily bring the new caste certificate which is issued on or after **01-09-2024** as well as old caste/community certificate which is issued before closing date of submission of online application at the time of Document Verification. The caste certificate belonging to the period between the closing date of submission of application will be cross checked with respect to the new caste certificate issued on or after **01-09-2024**. If any discrepancy is found between both certificates, his/her candidature will be treated against **Unreserved category**, provided the candidate fulfils the stipulations applicable for the entire cycle of the recruitment.

Candidates are advised to keep viewing the official websites of RRBs regularly for further updates.
