Q.1	What is the opening date of window period for submission of online application of CEN:02/2024 for existing candidates /new candidates as detailed in Corrigendum/Addendum No.2, dated 27.09.2024?
Ans.	The opening date for submission of online application is 02.10.2024 (00:01 Hrs).
Q.2	What is the closing date of window period for submission of online application of CEN: 02/2024 for existing candidates /new candidates as detailed in Corrigendum/Addendum No.2, dated 27.09.2024?
Ans.	The closing date for submission of online application is 16.10.2024 (23:59 Hrs) .
Q.3	Do existing paid candidates needed to pay application fee again?
Ans.	No, the existing paid candidates need not pay application fee again.
Q.4	Do existing paid candidates can change RRB and add/modify the posts, post preferences for all the categories notified (Cat. No. 02 to 40)?
Ans.	Yes, existing paid candidates can change RRB and add/modify the posts, post preferences for all the categories notified (Cat.Nos:02-40), if eligible.
Q.5	Do existing paid candidates get access for all the fields?
Ans.	They will get access only for educational qualification, re-uploading of photograph & signature, change of RRB and posts preferences for all Technician Grade-III categories (Cat.No.02 to 40). For details, please refer Para-3 of Important Notice, dated 27.09.2024.
Q.6	Can existing candidates submit new application?
Ans.	They should not submit new application as it will tantamount to multiple applications as per Para No. 1.5 of CEN: 02/2024 and summarily multiple applications will be rejected. For details, please refer Para-3 of Important Notice, dated 27.09.2024.
Q.7	Can new candidates apply and what are the conditions?
Ans.	New candidates can apply. For details, please refer Para-4 of Important Notice, dated 27.09.2024.
Q.8	Crucial date for educational qualification? Can candidates whose result expected after 16.10.2024 apply?
Ans.	Candidates (Existing/New) must possess their educational/ technical qualification on or before closing date of window period for submission of application i.e., 16.10.2024. Candidates waiting for final results of prescribed educational/technical qualification are not eligible to apply.

Q.9	What are post parameters (i.e., educational qualifications, medical standard & suitability of the posts for PwBD) for various posts of Technician Gr. III?

Q.11	What is the crucial date for reckoning age?
Ans.	The crucial date for reckoning age is 01.07.2024 . Please refer Para No. 5.0, 5.1 and 5.2 of the
	detailed CEN for further details.
Q.12	What is the crucial date to claim SC/ST/OBC/EWS status?
	Candidates seeking reservation on the basis of SC/ST/OBC/EWS status must ensure that they
	possess the community/category certificate as on closing date of window period for submission of
Ans.	application i.e., 16.10.2024. During DV, such candidates should produce their original
	community/category certificate (in prescribed format) valid as on or before the closing date of
	window period for submission of application i.e., on 16.10.2024 .
Q.13	What is the crucial date for PwBD certificate?
Ans.	PwBD candidates must possess their disability certificate on or before closing date of window
	period for online application i.e., 16.10.2024.
Q.14	I am currently serving in the armed forces can I apply as an Ex-Serviceman?
	You can apply as an Ex-Serviceman for this CEN:02/2024, if you will be released within one year
Ans.	from the closing date of window period for submission of online application i.e., Date of Discharge
	should be on or before 15.10.2025.
Q.15	What are dates of Modification window period?
Ans.	The modification window period is from 17.10.2024 to 21.10.2024 for existing/new candidates.
