(Reference CEN No.01/2019 of 28.02.2019)

Based on the performance in the Computer Based Test (CBT) - I conducted from 28.12.2020 to 31.07.2021 (in seven phases) and CBT - II conducted on 09.05.2022 for Level-6 and Computer Based Aptitude Test (CBAT) conducted on 30.07.2022, followed by Document Verification conducted from 18<sup>th</sup> October to 28<sup>th</sup> October 2022 with Block date on 31<sup>st</sup> October 2022 and on 28<sup>th</sup> November and 19<sup>th</sup> December, 2022, and medical examinations conducted thereafter, the candidates with the following Roll Numbers arranged in ascending order (not in order of merit) have been provisionally recommended for empanelment for the post of Station Master – Category No.2 of CEN 01/2019 (NTPC) in Part Panel IV.

The candidate's folders of the above said provisionally empanelled candidates is being forwarded to Principal Chief Personnel Officer, Southern Railway, Chennai. The indenting authority, i.e., the Office of the Principal Chief Personnel Officer, Southern Railway, has been informed about the shortfall of 21 candidates under the EWS quota for taking further action as deemed necessary.

One shortlisted OBC candidate has been declared 'Temporary Unfit' due to being pregnant. She will be considered when her Medical Fitness Certificate is received.

One shortlisted ST candidate selection is pending verification.

Candidature of all the candidates appearing in this provisional Panel is purely provisional and is liable to be cancelled, in case of any inconsistency/deficiency in the data furnished by them in their online application or at the time of DV or any malpractice on the part of candidates coming to the notice of RRB/Railways at any stage of the recruitment/appointment process.
