- 2.0 Candidates are advised to report to Railway Recruitment Board, Thampanoor, Thiruvananthapuram 695001, as per scheduled date and time mentioned above.
- 3.0 SMS/E-mail alerts are being sent to candidates' registered mobile / email ID for downloading their e-call letter.
- 4.0 The candidates called for DV should produce all the original documents, along with two sets of photo-copies in A4 size as detailed in the CEN. Candidates are also advised to bring six (6) coloured passport size photographs not more than one month old. Candidates should also bring Candidate's foil of e-call letter of CBT and e-call letter issued for Document Verification.
- 5.0 In case of variation in spelling in candidate's father's name/mother's name in the online application and original certificates/documents, on the date of verification, candidates are required to submit relevant affidavit executed before Magistrate or Notary on required stamp papers stating that the referred person in certificate (s) is one and same.
- 6.0 Candidates called for Document Verification will be sent for medical examination at the nominated Railway Hospitals located in the jurisdiction of RRBs on next day of DV. This will also involve travel from RRB to the city of Railway Hospital. The candidates are advised to come prepared to stay for more than four days for DV/Medical examination at their own cost. Candidates have to pay the prescribed medical fee of Rs 24/- only. In rare cases, where the investigation like CT Scan, Ultra Sound, tests to rule out refractive eye surgery etc., have to be carried out, for which necessary facility is not available in the Railway Hospital/Health Unit, candidates may have to make the requisite payment to the concerned laboratory/hospital for such investigation/ testing.
- 7.0 The candidature of all the shortlisted candidates is purely provisional and is liable to be cancelled at any stage of recruitment or thereafter, in case of any inconsistency/ deficiency/ discrepancy is detected in the information furnished by them or any malpractice on their part comes to the notice at any stage of the recruitment process or thereafter.
- **8.0** It is to be noted that merely shortlisting or calling a candidate for Document Verification/Medical examination does not entitle him/her in any way to an appointment in the Railways.
- **9.0** While every care has been taken in preparing the result, RRB reserves the right to rectify any inadvertent error or typographical/printing mistake etc. RRB regrets the inability to entertain any correspondence on this account from the candidates.
 - Important: Beware of the touts who may misguide the candidates with false promises of getting them selected for the job on illegal consideration.  - 2. Block date for verification of original documents for candidates absent on Regular DV date: 22-08-2025.
 - 3. Failure to report for document verification on Schduled date or Block date will tantamount to rejection of candidature and no correspondence in this context will be entertained.
